FUSION® XML MICRO-PARSER SOFTWARE LICENSE AGREEMENT

Rev. 14-December-01

Grant of License. In accordance with this Agreement, NetSilicon with its office at: 411 Waverley Oaks Road, Waltham, MA. 02452 grants: This NET+OS user (LICENSEE) a non-exclusive license to use the FUSION XML MICRO-PARSER (the SOFTWARE) and associated documentation for use on the NET+ARM platform only. This license to use is subject to the following terms and conditions

- 1. Copyright and Trademark.** FUSION is a trademark of NETSILICON. FUSION software, User Guide, and other supporting documentation are the sole property of NETSILICON and are protected by United States and worldwide copyrights. The LICENSEE acknowledges all NETSILICON claims regarding trademarks and copyrights associated with FUSION Software.
- 2. Definition of Use.** LICENSEE is granted perpetual, non-exclusive right to use FUSION software and associated documentation in the development of the specified product listed above. LICENSEE may modify the FUSION source software. Furthermore, LICENSEE may compile and assemble the SOFTWARE into object form. The specified LICENSEE product may contain this object form of FUSION, when combined with significant LICENSEE specific software that is different in purpose the SOFTWARE itself, without any per unit charges. Changes of target Processor and or Product Application from original product design will constitute a new product license. No restrictions on RTOS or Development tool changes.
- 3. LICENSEE Obligations.** LICENSEE agrees to take reasonable measures to protect all proprietary information and copyrights of NETSILICON in regards to the SOFTWARE. Furthermore, LICENSEE is strictly prohibited from disclosing the SOFTWARE source, documentation, or other proprietary information to any other parties, regardless of whether or not LICENSEE modified the SOFTWARE.
- 4. Transfer of Rights.** This license can not be assigned to any other party without prior written consent of NETSILICON. NETSILICON's consent will not be unreasonably withheld.
- 5. Termination.** This license will terminate without refund, under the following conditions: (i) LICENSEE files a bankruptcy petition or enters into an agreement to assign its assets for the benefit of creditors; or (ii) violates its obligations as defined by this Agreement and the failure has not been corrected within 30 days after notification by NETSILICON; If termination of this license occurs, LICENSEE must cease all use of the SOFTWARE and immediately return the SOFTWARE and associated documentation. Furthermore, LICENSEE must certify in writing to NETSILICON that LICENSEE no longer possesses or is using the SOFTWARE or documentation.
- 6. Warranty and Fitness.** The LICENSEE accepts the SOFTWARE as delivered, and NETSILICON accepts no responsibility to correct any defects found in the SOFTWARE. However, NETSILICON will accept requests for change for consideration in subsequent release(s) of the SOFTWARE and will respond to reported defects in a manner deemed acceptable by NETSILICON. Furthermore, LICENSEE agrees that it will not assert the SOFTWARE or documentation was offered as being fit for any particular purpose, whether or not such fitness was ever discussed between NETSILICON and LICENSEE.
- 6. Right of Audit.** NETSILICON reserves the right to authorize its independent auditors to inspect the records and products of the LICENSEE with respect to limiting the use of the SOFTWARE to only the licensed product(s). LICENSEE will be given notice of the intended visit of NETSILICON's auditors in writing. The exact date of the visit shall be determined by NETSILICON and LICENSEE, but must occur within 30 days of the notice to audit. Should LICENSEE be in violation of the limited-use nature of this Agreement, LICENSEE is obligated to pay for additional licensee fees and the entire cost of the audit, including travel and subsistence cost of the auditors, shall be levied upon LICENSEE. LICENSEE may also be liable for realized loss of revenue by NETSILICON which can be attributed to the LICENSEE's violation of this Agreement. However, should LICENSEE be in compliance with this Agreement, the entire cost of the audit would be paid by NETSILICON.
- 7. Choice of Law.** This agreement shall be interpreted, construed and enforced in accordance with the laws of the Commonwealth of Massachusetts without respect to its conflict of law provisions.
- 8. Entire Agreement.** This Agreement contains the entire agreement between NETSILICON and LICENSEE and there are no other promises or conditions in any other oral or written agreement.
- 9. Indemnification.** NETSILICON shall defend and hold LICENSEE harmless, at NETSILICON's cost and expense, against any suit alleging infringement of a patent, copyright, trade secret, or other proprietary right, brought against LICENSEE to the extent that such suit pertains to the use of the SOFTWARE.
