

END-USER LICENSE AGREEMENT

EARLY AVAILABILITY

This end-user license agreement is a legal agreement between you (either an individual or a single entity) and Digi International Inc. ("Digi") for use of Early Availability Digi Technology. This license applies to the product with which it was shipped, which may be a Development Kit or a unit of Digi Hardware. By using the Early Availability Digi product, you are consenting to be bound by and are becoming a party to this end-user license agreement. ALL DIGI EARLY AVAILABILITY PRODUCTS ARE INTENDED FOR EARLY PRODUCT EVALUATION, DEVELOPMENT, AND PROTOTYPING PURPOSES ONLY, AND MAY NOT BE USED IN PRODUCTION ENVIRONMENTS.

DEFINITIONS

- "Early Availability" refers to the status of hardware or software components that are still under active development, have not completed product design verification, and/or quality assurance.
- "Digi Hardware" shall mean electronic assemblies and accessories provided by Digi, under the Digi brand name.
- "Digi Software" shall mean the computer software code that is distributed by Digi and not subject to third-party ownership rights.
- "Digi Technology" refers to Digi Hardware and Digi Software.
- "Development Kit" refers to a combination of Digi Hardware, Digi Software, and documentation and may also include third-party components.

Early Availability Digi Software is covered by copyright and licensed (not sold).
